In accepting this order, Vendor and its subcontractors agree to comply with all specifications/requirements defined by this order, shown on our part drawings, or otherwise provided. All material will be subject to inspection and approval of Milwaukee Tool after delivery. The right is reserved to reject and return at the risk and expense of the Vendor such portion of any shipment which may be defective or fails to comply with specifications without invalidating the remainder of the order. 4. QUANTITY. Delivery of any material over and above the actual quantity specified on this order will be at the risk of the Vendor and payment will not be made for such over-runs unless arranged with Milwaukee Tool in advance in writing. Do not overship without permission. 5. DRAWINGS, TOOLING, ETC. All drawings, computer files, artwork tooling, pages, special fixtures or other properly furnished or paid for by or charged to Milwaukee Tool shall belong and be returnable to Milwaukee Tool upon demand, without penalty or additional cost, and in good condition, ordinary wear or use excepted.
